

Annual Report 2014

Introduction

The Norway Chapter of the Internet Society ("ISOC Norge") was formally reinstated on June 20 2013 after a period with an interim board of directors. The updated bylaws was approved by the Internet Society on May 8 2013.

Chapter activities

The board has focused their work in recruiting new members, organize member meeting and be invited to the general discussion of Internet in Norway.

ISOC Norge has organized two meetings for members in the period.

The first meeting (October 24 2013) covered privacy on the net. A panel included high profiled participants (Jon Wessel-Aas and Gisle Hannemyr) discussed the Snowden case in relation with the situation in Norway.

The meeting attendance was good, approximate 30 persons.

The second meeting (June 24 2014) was more informal and was held in a coffeeshop. The topic was "The Internet in the past, present and the future".

The number of attendees were approximate 15.

In addition to the above, ISOC Norge has attended the NORPOL meetings held in this period. Norpol is the policy advisory board for the .no domain. Norpol has representatives from the private sector, the government, the Internet industry, consumer authorities and other relevant stakeholders (http://www.norid.no/regelverk/norpol/index.en.html)

The chapter has regularly updated the ISOC Norge website (http://isoc.no) and the Facebook profile.

In connection with the selection of Rolf Nordhagen (1927-2013) to the Internet Hall of Fame, ISOC Norge published a press release.

The chapter participated in the public hearing ".NO domener for privatpersoner". ISOC Norge was in favour of individuals being eligible for registrations directly under .NO.

ISOC Norge gave a presentation about the chapter and the Internet Society at The Gathering (http://www.gathering.org) in April 2014.

Economy

In accordance with the bylaws, the membership is free. The activities are based and held at a low cost level, based on voluntary work.

Income
